ACCOMPLISHMENTS

- Twenty-three years experience as a sworn law enforcement officer, supervisor, and manager. Career highlights include: regional criminal justice training academy director; staff support commander; patrol commander; research/development commander.
- Thirty years experience successfully managing large-scale criminal justice training and technical assistance projects as a Federal Government contractor. Project management skills include conducting management studies of police operations and procedures; effective budget development and control; managing supervisory and operational project staff; selecting, hiring, and training consultants; training program development and delivery; strategic planning and long-range goal setting; implementing personnel performance evaluation criteria; developing and implementing project performance benchmarks; writing grants, reports, and articles; coordination of all project activities.
- Serves on the Advisory Board, National Forensic Science Technology Center at Florida International University, www.nfstc.org, which supports the justice and defense communities through innovative forensic science programs, evaluation of the latest forensic technologies, forensic science training and laboratory quality reviews.

- Managed the Police-Community Collaboration Toolkit Project for the Office of Community Oriented Policing Services (COPS), U.S. Department of Justice. Revised and expanded a toolkit to be used by law enforcement agencies to develop and facilitate partnerships with community organizations to enhance community policing.
- Directed the National Clandestine Laboratory Enforcement Training Project for the Office of Community Oriented Policing Services (COPS), U.S. Department of Justice. This project provided a wide array of training courses to public safety agencies and communities on laboratory recognition, hazard identification, and response procedures. The project developed collaborative interagency responses to clandestine laboratories. Over a three-year period, this project delivered training to over 10,000 public safety personnel in 30 states and Puerto Rico.
- Delivered EPA's first responder clandestine methamphetamine lab training via a subcontract with CSRA International. This program trained operational personnel to respond to incidents in a defensive fashion within existing resources and capabilities. This training used a combination of tabletop exercises, classroom presentations, and

practical demonstrations to provide those skills necessary to safely manage initial environmental responses to methamphetamine labs.

- Associate Project Director for the Cops in Schools Program, a multi-year COPS-funded project. Under this national training and technical assistance initiative, provided conference planning and management and technical support services for 20 separate training sessions involving 3,300 school administrators and school resource officers representing COPS grantees.
- Project Director for the Model Clandestine Laboratory Enforcement Program, funded by the Bureau of Justice Assistance (BJA), U.S. Department of Justice. During its 5-year history, this national training project provided assistance on clandestine laboratory enforcement and cleanup to more than 5,000 officials in nearly 600 law enforcement agencies nationwide.
- Associate Project Director for the Problem Solving Partnerships Training and Technical Assistance Project, funded by COPS. This program involved planning, development, and delivery of four regional conferences to provide training on the effective use of the SARA (scanning, analysis, response, and assessment) model of problem-solving partnership for COPS grantees and their community partners.
- Directed the National Institute of Justice (NIJ, USDOJ) funded Professional Conference Series (PCS). Responsibilities included conceptualizing and developing all PCS conference, workshop, training, and focus group agendas. This effort required constant interaction with the NIJ director, U.S. Department of Justice officials, project consultants, and other high-level federal, state, and local government officials and policy makers.
- Directed the BJA-funded Narcotics Control Technical Assistance Program, which provided narcotics enforcement training and technical assistance to more than 5,000 law enforcement officers in 40 states and territories. Responsibilities included: developing and delivering numerous drug enforcement training courses (including course objectives, student manuals, instructor guides, audiovisual aids, and evaluation instruments) suitable for all levels of law enforcement personnel, from narcotics officers to high-level policy makers.
- Selected as the NIJ law enforcement Visiting Fellow while employed by the Arlington County Police Department. Conducted a 1-year, national research study into current practices in field training officer (FTO) programs. This study produced a major report designed to assist law enforcement agencies in implementing and improving FTO programs. The majority of U.S. law enforcement agencies currently use the model FTO program published in the report.
- Managed the Center for Innovative Public Policies' (CIPP) Prison Rape Elimination Act (PREA) Training and Technical Assistance Program. Activities included: managing sub-contractors, developing policies, conducting training, coordinating with other TA providers, and delivering presentations to a diverse group of criminal justice consumers.
